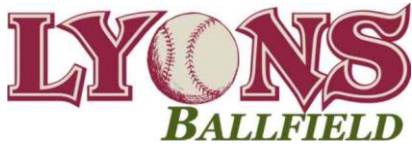
**USA Softball 23U  
National Invitational Tournament  
Aug 1<sup>st</sup> and 2<sup>nd</sup> 2026**

1. The tournament is a USA sanctioned tournament. Saturday will be Round Robin play followed by Elimination play. **Each team is guaranteed a minimum four games!**
2. Winners are awarded a team trophy.
3. Team registration is \$550 if postmarked two weeks prior to the start of the tournament or \$600 if less than two weeks from the start of the tournament.  
Registration closes the morning of the Sunday prior to the tournament.
4. Checks should be made payable to LFCAA.
5. If maximum amount of teams is reached prior to date, additional teams will be placed on a wait list. If enough additional teams are placed on wait list, pools may be created based on field availability.
6. Teams that withdraw two weeks prior to 10 days before the start of the tournament will be refunded half of their registration fee.
7. Teams that withdraw less than 10 days before the start of the tournament will not be refunded any part of their registration fee.
8. A schedule will be available the Sunday evening prior to the tournament scheduled date.
9. All teams must carry team insurance and present proof of insurance with registration or prior to first scheduled tournament game.
